

## FINAL TERMS FOR CERTIFICATES

### 4. Reasons for the Issue, Estimated Net Proceeds and Total Expenses

- (a) Reasons for the Issue: A small portion of the net proceeds from the issue of the Securities will be allocated to finance the research on Alzheimer's disease and other forms of dementia by the Alzheimer's Foundation. Should the project fail, the relevant part of this portion of the proceeds would be reallocated to other projects supported by the association.

The payment of the donation will be made by Captain Cause, an intermediary facilitating corporates' donations to charities.

The remaining balance of the net proceeds of the issue of the Securities will be allocated or reallocated from time to time to the financing and/or refinancing, in whole or in part, of Eligible Social Assets as defined below and further described in the BNP Paribas Social Bond Framework dated November 2023 available on <https://invest.bnpparibas/en/document/social-bond-framework-november-2023> as may be amended from time to time by the BNP Paribas or any of its affiliates (the "**BNP Paribas Social Bond Framework**").
